CITIZEN'S POLICE ACADEMY

In order to enhance and develop citizen awareness and understanding of the police role in the community, the Johnson City Police Department has developed a Citizen's Police Academy. This concept in law enforcement is designed for citizens of different backgrounds and occupations.

The program consists of 45 hours of police training including much "hands on" instruction. Areas covered are traffic stops, investigation procedures, S.W.A.T., K-9, vice and narcotics investigations, firearms, self-defense instruction, and required ride-a-long, hiring and selection process, support services, 9-1-1 functions and records division.

The objective of this course is not to make the "graduates" of this course police officers, but better-informed citizens with a greater general knowledge of our many functions and foster enhanced community relations from these graduates and the people they touch in every day life.

REQUIREMENT AND LIMITATIONS

Citizens applying for the Citizen's Police Academy must adhere to the following standards:

1. Must be 21 years of age or older;
2. No criminal history other than minor traffic violations;
3. Physically able to meet training requirements;
4. Must attend one night per week (3 hours) and one Saturday, (8 hours);
5. Must ride for two 8-hour shifts on patrol; and
6. Must sign all required waivers and agreements

Due to classroom size, the Academy will be limited to 20 persons per academy. Attending the Citizen's Police Academy is a privilege, not a right, and applicants will be accepted on a first-come, first-serve basis and are accepted pending background investigation, and approval by the Chief of Police.
